\$5,640 in dues outstanding. If everyone pays the first month we will have earned \$600 extra from late fees.

Republic Waste Management has agreed to direct bill property owners for any overage rather than billing LVPOA. For example, extra pick-up, receptacle exchange, over filled receptacle, etc. This means our trash bill from here on out should be stable \$1,452.25 with no fluctuations.
